

# CONSENT FORM

## for Use of Personal Data and Photos / Video Recordings of Minors in IJSO2024

### Purpose

This consent form is designed to ensure compliance with the EU General Data Protection Regulation (GDPR) 2016/679 regarding the use of personal data, photographs, and video recordings of minor (**the Participant**) participating in the 21st edition of the International Junior Science Olympiad in Bucharest, Romania from 2<sup>nd</sup> to 12<sup>th</sup> of December 2024 (**the Olympiad**).

### Data Controller

**NUST POLITEHNICA Bucharest - the Organizer** will act as the data controller for the photographs, video recordings, and personal data collected.

### Type of Data Collected

1. Photographs and video recordings of the minor participating in the Olympiad (Type 1).
2. Personal data: minor's name, surname, represented country / team (Type 2).
3. Personal data: date of birth, passport data, dietary and medical needs (Type 3).

### Purpose of Data Collection

The photographs, video recordings, and personal data will be used for the following purposes:

1. Promotion of the Olympiad (Types 1 and/or 2).
2. Publication on the Olympiad's website and social media channels (Types 1 and/or 2).
3. Use in press releases and other promotional materials regarding the information about the Olympiad (Types 1 and/or 2).
4. Verification and identification purposes related to the Olympiad (Types 1 and/or 2 and/or 3).
5. Archival purposes (Types 1 and/or 2 and/or 3).

### Legal Basis for Processing

The legal basis for processing this data is the explicit consent provided by the parent/guardian of the Participant.

### Data Storage and Retention

The data will be stored securely and retained for a period of 5 years after the Olympiad, unless otherwise required by law. After this period, the data will be securely deleted.

### Rights of Data Subjects

As the parent/guardian, you have the right to:

1. Access the personal data the Organizer holds about your child (the Participant).
2. Request the rectification or erasure of your child's personal data.
3. Restrict or object to the processing of your child's personal data.
4. Withdraw your consent at any time without affecting the lawfulness of processing based on consent before its withdrawal.
5. Lodge a complaint with a supervisory authority.
