Rights of Data Subjects

As the parent/guardian, you have the right to:

- Request the rectification or erasure of your child's personal data.
- Restrict or object to the processing of your child's personal data.
- Withdraw your consent at any time without affecting the lawfulness of processing based on consent before its withdrawal.
- Lodge a complaint with a supervisory authority.
